## **Terms and Conditions of Admission**

- 1. The admission of a candidate shall be cancelled if it is found that the admission has been secured on the basis of furnishing false documents/incorrect information to the JRU.
- 2. Any change in name/address is required to be intimated to the university authorities' immediately in writing so that correct information is maintained in the office records of the university.
- 3. No firearms, weapon or potentially dangerous instrument shall be carried to/stored in the campus or carried in person by any students. Those found guilty will be expelled.
- 4. The admission letter, prospectus, information brochure and website of the JRU are the correct and only guide to the terms and conditions of admission and the rules and regulations of the JRU. Students are advised to refer to the same for clarification. No other form of communication other than those mentioned, whether written or verbal is there between the university and the students.
- 5. The candidate has clearly understood the mode and manner of education and the degree/diploma/certificate to be awarded to him after successful completion of the course.
- 6. Fees once paid are not refundable for any reason whatsoever. 50% of the registration amount will also be refunded provided that the students applies for refund prior to one month before the commencement of the session.
- 7. The university reserves the right to cancel the admission of any candidate under any of the following circumstances:
  - a) If the fees is not deposited by the stipulated date.
  - b) If the candidate fails to furnish the proof of the stipulated minimum qualifications required for admission into the program. Provision of Non Refund of Fees under Clause 13 will also apply to sub clauses (b) and (c).
- 8. No dispute shall be raised after the expiry of one month from the date on which the process of admission and / or selection is completed. The dispute shall be subject to arbitration to be adjudicated upon by sole arbitrator being a retired Judge of a High Court and the same shall be binding on the parties.
- 9. Any request for refund has to be made in writing. The application shall be decided by the refund committee based on the mitigating circumstances for the refund sought. Normal processing time will be taken in this process. Any dispute /disagreement in the same shall be referred to arbitration to be adjudicated upon by sole arbitrator being a retired Judge of a High Court and the same shall be binding on the parties.
- 10. This letter is complete in itself and defines clearly what a candidate will be getting on completion of the course.
- 11. All admissions are entirely at the discretion of the management of the university and no explanation will be given in case of refusal .
- 12. The submission of complete admission fee implies the consent of the student to the rules and regulations of the

- 14. Authenticity of any document attached along with the admission / Re registration form shall be the responsibility of candidate.
